Dear Sudbury Electricity Customer,

**You will be automatically enrolled in the Sudbury Community Electricity Aggregation product, "Sudbury Standard", unless you affirmatively opt out by mailing and postmarking the enclosed opt-out card by December 4, 2024.**

The Town of Sudbury is offering a program called Sudbury Community Electricity Aggregation (Sudbury CEA). The Program is a carefully designed alternative to your current electricity supply options that include those offered by Sudbury and other third-party electricity suppliers. By implementing the Program, Sudbury aims to provide electricity products that increase our community's renewable energy use and reduce carbon pollution.

## YOUR OPTIONS

Your participation in the Program is voluntary. You can leave the Program at any time without penalties or fees.

- 1 Automatically enroll in Sudbury Standard, which adds voluntary renewable energy (National Wind RECs) to total 100%** If you take no action, you will be automatically enrolled in the default product, Sudbury Standard, starting on your next available meter read. The electricity supplier for the Sudbury Community Electricity Aggregation Program is Dynegy.
- 2 Choose to enroll in another Sudbury product with more or less renewable energy content** To choose a different product, call the program's electricity supplier, Dynegy, at (866) 220-5696, or submit an online request at [Sudbury-CEA.com](http://Sudbury-CEA.com).
- 3 Choose to continue with Eversource Basic Service** To remain with Eversource Basic Service for your electricity supply, you must opt out. To opt out before being automatically enrolled, you must take one of the following actions before **December 4, 2024**:

**The Sudbury Community Electricity Aggregation Program cannot guarantee savings compared to Eversource Basic Service for the duration of the Program pricing as future Basic Service rates are unknown.**

Program prices could also increase as a result of a change in law that results in a direct material increase in costs during the term of the electric supply contract. Program prices include a commission fee of 0.1 ¢/kWh for the aggregation consultant. Program prices also include taxes which are billed as part of the power supply charge.

Sudbury Community Electricity Aggregation prices apply to service beginning and ending on the days of the month that your meter is read. Rates indicated above are for Supply Services only.

Some products contain additional Renewable Energy Certificates (RECs) above that required by MA law. The additional RECs qualify for MA Class I designation from generation located within, or delivered to, New England.

## RENEWABLE ENERGY DETAIL

The Commonwealth of Massachusetts requires that all electric supply products include a minimum of 62% renewable energy resources in 2024, 63% in 2025, 69% in 2026, and 75% in 2027. Some program products, as shown below, contain additional renewable energy that exceeds the minimum required by the Commonwealth.

## PROGRAM DETAIL

- Eversource will continue to deliver the electricity that you use in your home and is responsible for the delivery charges that appear on your monthly bill. If you have questions about the delivery portion of your bill, contact Eversource at (800) 592-2000, or by visiting <https://www.eversource.com/content/residential>.
- The Program is served by Dynegy, DPU license number CS-166, (866) 220-5696, <https://www.dynegy.com/>.
- You can switch to a different program supply product any time after you've enrolled.
- Budget Plan or Eligible Low-Income delivery rate consumers will continue to receive those benefits from Eversource.
- Solar Electricity Consumers will not be impacted and will continue to receive their net metering credits while participating in the Program.
- You can leave the Program with no associated early termination fees any time after you've enrolled. If you leave the Program, your account(s) will be returned to Eversource Basic Service on the next available meter read.
- Exit Terms for Basic Service: There is no penalty charge for leaving Eversource Basic Service, however, Large Business customers may receive a billing adjustment charge or credit.

- If you are receiving electricity supply from a competitive supplier and believe you have received this opt-out letter in error, you must sign and return the enclosed opt-out card. This will ensure you continue to receive your electricity from that competitive supplier and prevent any possible early termination fees.
- Tax-exempt small business customers participating in the Program must provide a copy of their Tax Exemption Certificate directly to Dynegy via email at [Salestax\\_geotax@vistraenergy.com](mailto:Salestax_geotax@vistraenergy.com), or mail at Dynegy, ATTN: Customer Care, P.O. Box 650764, Dallas, TX 75264 in order to maintain their tax-exempt status.
- If you participate in the Program, you will be automatically enrolled at a new price at the end of the contract term unless you inform the Town otherwise. The new price may be higher or lower than the existing price, and the voluntary renewable energy content may change. The Town will contact you no later than 30 days before each automatic renewal to notify you of your supply options.
